



PRESCHOOL FOR 2 YEAR-OLDS, 3 YEAR-OLDS & 4 YEAR-OLDS (VPK Provider) 2011-2012

PRESCHOOL is for 2, 3, and 4 year-olds and is offered for full or part-time participation. This is a loving but structured environment within which a child develops learning skills. Preschool is offered on a school year basis or as a year-around program.

Application/Registration Fee (non-refundable): \$50.00 (for non-VPK participants) (Includes school-time student accident insurance, books, and field trip bus expense.)

SCHOOL YEAR ENROLLMENT — AUGUST 2011—MAY 2012

These tuition rates apply to the traditional school year.

* The full day schedule is 6:45 a.m.– 6:00 p.m. The classroom period is 8:15 a.m. – 3:00 p.m. Students arriving before 8:00 a.m. or staying after 3:15 p.m. will be in a supervised day care program.

** Second Child Discount applies when an older sibling is enrolled at Keswick.

TUITION SCHEDULE*

Tuition may be paid by one of the following plans:

- (1) **By the year in advance** – (2% discount will apply if paid prior to August 1, 2011)
- (2) **By the semester in advance** – July 1st and January 1st
- (3) **Ten equal payments** – June 2011 through May 2012 except July & August
- (4) **Twelve equal payments** – June 2011 through May 2012

*10% of the annual tuition is non-refundable if the student does not attend in the fall.

Parents who choose the 10 or 12 month payment plan must pay by electronic bank debit (ACH). The payment choices are:

- (1) full payment on the 1st
- (2) half payment on the 1st, half payment on the 15th
- (3) full payment on the 15th

PAST DUE ACCOUNTS

A late fee of \$30.00 will be added to accounts 10 days after the scheduled due date, plus a 1% carrying charge on the unpaid balance. If an account is not paid within 60 days, the parents may be asked to withdraw their child(ren) from school. Payments not honored by the bank will incur a \$30 insufficient funds fee.

YEAR-AROUND ENROLLMENT

Summer camp is available for an additional charge of \$100.00 weekly and runs for 7 weeks. Children must be 3 to participate in the summer camp. Dates for the 2011 summer camp will be available March 1, 2011.

AFTERCARE LATE FEES

A \$5 fee will be charged for every fifteen minutes (or any part thereof) that your child is left past 6:00 p.m.
